# Flashback to how Callaway site was bought

Callaway Plant may be a long way from completed but it is finished, practically, as far as the Real Estate Department is concerned. And for three representatives of that department there are fond memories of five years in

Callaway County, taking care of their part of the job.

It was in February 1973 that their department manager, **Gene Arras**, sent the trio out to buy the site selected by Nuclear Engineering. The three, **George Horton**, **Dave Shaw** and **Rich Eidman**, all had long experience in land buying for the company.

"As in all purchasing of Land for a utility, we had to keep the identity

of the purchaser a

secret," Horton says. "It was a formidable challenge to acquire something over 5,000 acres of land without disclosing the name of the purchaser. First we found a few tracts that were for sale and managed to buy them with a minimum of negotiation. This established the going price for Callaway County farmland and gave us a basis for negotiating with the remaining owners." Between February and July 16, when the company's plans were made public, Horton, Shaw and Eidman bought 5,080 acres. After the announcement,

bargaining stiffened but they managed to close deals on the remaining 2,107 acres needed. Average price paid was \$486 an acre prior to disclosure.

"That's just about what others are paying for land in Callaway County in 1978," Shaw points out with some pride.



### **Eminent Domain News**

Municipal Entities Can Join Mo. Ballot Lawsuit Last Edited: Tuesday, 02 Sep 2008, 12:36 PM CDT Created: Tuesday, 02 Sep 2008, 12:36 PM CDT

JEFFERSON CITY, Mo. (AP) -- The Missouri Chamber of Commerce and Municipal League can join a lawsuit over an eminent domain ballot measure. They are seeking to keep the proposed restrictions off the November ballot.

The secretary of state's office ruled last month that supporters of two proposed constitutional amendments on eminent domain didn't gather enough signatures. The measure's backers have sued to challenge that. The proposed restrictions would bar the use of eminent domain by nongovernment entities and for private use.

Cole County Judge Richard Callahan on Tuesday allowed the Chamber of Commerce, Municipal League and other entities to join the lawsuit.

Those groups argue that the proposed constitutional amendments would hinder economic growth and infrastructure projects, and they want to keep it off the November ballot.
