Thank you course facilitators, past officers, committee chairs and members for your participation and dedication, and allowing me the opportunity to serve the Chapter, I look forward to working with you all.



Joint Chapter Meeting

Please join us for a Joint Meeting with Chapter 5 to be held May 8th at the Willmore Lodge, Lake Ozark, Missouri. Bryan Vance, AmerenUE Field Coordinator will have a presentation on the history of Bagnall Dam, shoreline management and environmental challenges associated with the lake.

Willmore Lodge History

This historic log building was completed in 1930 for Union Electric, by Stone and Webster Engineering Corporation and designed by Louis La Beaume, a noted St. Louis architect and partner in the architectural firm of La Beaume and Klein. La Beaume's resume included work on the Louisiana Purchase Exposition (the 1904 World's Fair), a member of the St. Louis City Plan Commission, and president of the St. Louis Art Museum. His design and plan was two years in the making and was approved by Union Electric President Louis A. Egan, whose name the lodge informally bore in its early years. Early documentation refers to the lodge as an administrative building, although the amenities and interior layout indicates a plush retreat and entertainment facility for Union Electric during the early years of the Great Osage River Project.

The Great Osage River Project is recognized as one of the greatest engineering and construction feats of its time. Site work began on August 6, 1929 by Union Electric Company of St. Louis, Missouri and the Stone and Webster Corporation. The final price tag would be \$30 million for the last and largest major dam to be built in the United States entirely with private capital. Four months after construction began, the stock market crash followed by years of the Great Depression. The undertaking created a gold rush type scene. News spread quickly and prospective employees began pouring into the area. They came by foot, horseback, river, piled high in trucks, and a few in automobiles. The area was so remote that roads were dirt and the nearest railway stopped 15 miles away in Eldon. During the worst depression that the United States had ever seen, Union Electric created nearly 10,000 new jobs and, at that time, the largest man-made lake in the world. There were some 4,600 craftsmen and laborers working at one point in time, twenty-four hours per day and seven days per week. During the next two years, the project would see 20,500 workers come and go. Before the Project started, this land was sparsely populated. Most of the residents were settlers who came because of the 1864 Homestead Act. That Act allowed 160 acre tracts of land to be deeded, at \$1.25 per acre. Union Electric created its own city. Dormitories and mess halls were built first, followed by a hospital, concrete plant, miles of roads, and even a jail for the rowdy misbehavers. Copyright Lake Area Chamber of Commerce

The SR/WA Designation

SR/WA - Senior Member, International Right of Way Association - is the most prestigious professional designation granted by IRWA to members who have achieved professional status through experience, education and examination.

The SR/WA designation requires training and examination in several major right of way disciplines. The SR/WA designation says, "I have more than five years of right of way experience, plus I have had formal training in a wide variety of right of way areas."

The SR/WA professional may be a specialist in one area such as acquisition, relocation or law, but also must be familiar with the other disciplines associated with the right-of-way profession. The SR/WA designation is the only designation reflecting evidence of professional attainment in the right of way field.



Chapter 37 has had the privilege of having Richard Schreiber as an IRWA member since the 1970's and was the Chapter President in 1987. He also obtained a JD Degree from St Louis University School of Law and has been engaged in the private practice of law in the St Louis Metro Area for many years.

Mr. Schreiber was certified to instruct IRWA classes in 1984 and has been teaching ever since. He is qualified and has taught property law & ethics, Negotiations & skills of the expert Testimony, Legal aspects of easements and most recently eminent domain.

The most significant change Mr. Schreiber has experienced in the past thirty years is in the chapter's growth. When he first became a member there were twenty-five to thirty active members. Today; however, the chapters membership is near one hundred, with many having obtained or in the process of obtaining their SR/WA designation. He also states the membership of the chapter is more diverse and has taken a greater interest in international programs.

In the right of way industry itself, Mr. Schreiber sees the most significant change in the condemnation process. Due to the fear of huge verdicts, those who condemn right of way are settling more cases. The addition of notice provisions to property owners and the expanded use of appraisals at every stage of the process are also big changes in the way right of way business is completed.

It is Mr. Schreiber's belief that IRWA's biggest challenge in the next decade will be its continued growth in a changing economy and adapting to the changing energy scene in the country.
